



MEDIA ACCREDITATION RULES

We kindly invite you to get acquainted with the media accreditation rules.

BASIC PRINCIPLES OF ACCREDITATION

By submitting the application for accreditation, the media representative undertakes to properly and correctly inform the audience of the represented media about the event before, during and after the event.

The media representative submits the prepared material (photo gallery, video, article prepared by the journalist, etc.) to the organizer of the competition to e-mail zane.lielkaja@gmail.com - NOT later than 3 days after the end of the motorsport event. If this instruction is not complied with, the organizer reserves the right not to approve the accreditation application for the media representative in the following events.

The media accreditation is envisaged for:

- **journalists;**
- **media photographers;**
- **TV/video cameramen;**
- **representatives of competitors.**

Only persons **having reached the age of 18** will be accredited.

Accredited media representatives are **STRICTLY FORBIDDEN** to use drones or any other ground-controlled flying device, **if they don't have received permission by the organisers.**

MEDIA TABARDS

Media representatives willing to receive accreditation, media tabard and be entitled to be present in dangerous areas of the track shall have **life insurance policy (including for motorsports competitions) with the value of at least EUR 3000.**

Media tabards for accredited media will be available for a guarantee fee of EUR 20.

The accredited media representative with the media tabard issued by the organiser of the event is entitled to be present in the especially envisaged media zones and no further than 1 (one) meter away of the safety demarcation (fence, stripe, other) of the dangerous areas of the track.

Handing over of the received media tabard or media armband to another person is strictly prohibited.

SUBMISSION AND APPROVAL OF MEDIA ACCREDITATION APPLICATIONS

The accreditation application must be filled in official website www.axlatvia.lv, in the section "Media accreditation".

Organiser will not assess Applications that are incomplete.



Granting and/or rejecting accreditation is fully in the hands of the Organiser. The Organiser reserves the sole right to distribute media armbands to selected media.

Confirmation of the granting or rejection of accreditation to media representatives (to the e-mail indicated in the accreditation application) will be sent within five working days after receipt of the accreditation application.

ISSUE OF ACCREDITATION

Accredited media representatives will be able to receive and hand over media cards and media tabards at Media center.

Media cards and media tabards can only be received personally.

! It is forbidden to share equipment with other media.

By completing the application you confirm that you have become acquainted with the Media Accreditation Rules and Media Safety Rules and resolve to comply with the above.

The organizer of the competition reserves the right to withdraw the accreditation card and / or media tabard granted to the media representative if it violates the safety rules of the media representatives and / or the media accreditation rules and / or does not follow the instructions of the track judges.
